I understand that if balances are not paid within 2 weeks of being issued, the management reserve the right to cancel my child’s chargeable additional session and/or lunches in the Nursery and any unpaid debt will be passed on to the East Riding Council debt collection team.
- I understand that if my child is absent from nursery due to illness or holiday, the balance still requires full payment. This secures my child’s paid nursery hours/lunchtime sessions.
